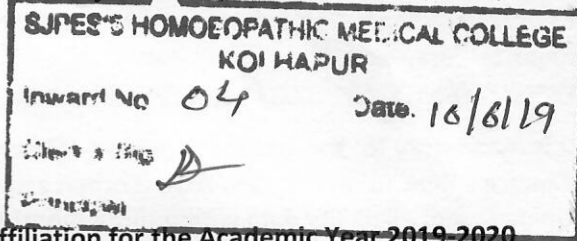

1. As per the provision under Section 65 (4) of Maharashtra University of Health Sciences Act, 1998, I am directed to communicate the decision of the Academic Council taken in its meeting held on 27/05/2019. The Academic Council has unanimously resolved vide its resolution No. 56/2019 to grant Continuation / Extension of affiliation to the B.H.M.S. course of your college for the academic year 2019-2020 subject to following conditions:

- The intake capacity shall be 75
- As per grant of permission from Govt. of India, Ministry of Health & Family Welfare, Department of AYUSH/Central Council of Homoeopathy/State Government (as applicable).

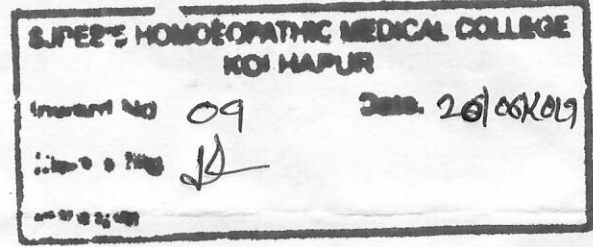
