Subject: Application of Shri Jagadguru Panchcharya Education Society's Homoeopathic Medical College, 200, E, Tararani Chowk, Kolhapur, Maharashtra - 416003 for permission with intake capacity of 75 seats in BHMS course and 06 seats of post graduate course in MD(Hom.) in 02 subjects namely Practice of Medicine (03 seats) and Paediatrics (03 seats) for A.Y. 2023-24 under section 29 of NCH Act 2020 - regarding

Sir,

Shri Jagadguru Panchcharya Education Society's Homoeopathic Medical College, Maharashtra has submitted an application for permission for sanction of 75 seats in BHMS course and 06 seats of post graduate course in MD(Hom.) in 02 subjects namely Practice of Medicine (03 seats) and Paediatrics (03 seats) for the academic year 2023-24. The College has submitted the Part 1 information in which the entire functional profile has been narrated. MARB has examined the profile of the College as to whether the college fulfils the Minimum Standard requirements to be fulfilled as per the prevailing regulations under NCH Act 2020. As per the observations made by MARBH, following lacunae are to be rectified with immediate effect. College shall fulfil all functional requirements as per the Minimum Standard requirements.

- Case records should be well maintained in respect of case analysis, evaluation and repertorization. All case records shall be written with entire case details and follow ups and made available in medical records room for academic progress for students and follow up attendance of patients. Case sheets should have complete demographic details and contact details of patients.
- Diagnosis should be written in ICD 11 criteria.


Considering the above observations, and facilities available, MARB has decided to issue permission to Shri Jagadguru Panchcharya Education Society's Homoeopathic Medical College, 200, E, Tararani Chowk, Kolhapur, Maharashtra - 416003 for conducting BHMS course for the academic year 2023- 24 with intake capacity of 75 seats in BHMS course and 06 seats of post graduate course in MD(Hom.) in 02 subjects namely Practice of Medicine (03 seats) and Paediatrics (03 seats). All shortfalls mentioned shall be rectified within a period of 15

days or before counseling initiates whichever earlier, and compliance report shall be submitted to the undersigned, failing which the permission issued will be withdrawn without further notice.

All admissions shall be made from NEET/AIAPGET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India Quota. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/ UT govt as designated by Central Government and counseling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the central govt for All India quota or the student admitted thereunder.


The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/AIAPGET qualified students will not be approved by Medical Assessment and Rating Board.
